### **STRATEGIC GOODS (CONTROL) ACT 2002**

### **STRATEGIC GOODS (CONTROL) (AMENDMENT) REGULATIONS 2025**

In exercise of the powers conferred by section 38 of the Strategic Goods (Control) Act 2002, the Minister for Trade and Industry makes the following Regulations:

#### **Citation and commencement**

1.—(1) These Regulations are the Strategic Goods (Control) (Amendment) Regulations 2025 and, except for regulation 4, come into operation on 1 December 2025.

(2) Regulation 4 is deemed to have come into operation on 31 December 2021.

#### **Amendment of regulation 2**

2. In the Strategic Goods (Control) Regulations (Rg 1) (called in these Regulations the principal Regulations), in regulation 2(1), replace the definition of “SG Order” with —

““SG Order” means the Strategic Goods (Control) Order 2025 (G.N. No. S 660/2025).”.

#### **Amendment of First Schedule**

3. In the principal Regulations, in the First Schedule, replace item 1 with —

“1. Guns, Explosives and Weapons Control Act 2021.”.

**Miscellaneous amendments****4. In the principal Regulations —**

- (a) in regulation 12A, in the regulation heading, replace “**section 6(6)**” with “**section 6(7)**”;
- (b) in regulation 12A(1), replace “section 6(6)” with “section 6(7)”;
- (c) in regulation 13(4), in the definition of “free trade zone”, replace “(Cap. 114)” with “1966”;
- (d) in regulation 24, replace “sections 5(6), 6(8)” with “sections 5(7), 6(9)”;
- (e) in the First Schedule, in item 2, replace “(Cap. 37B)” with “2000”;
- (f) in the First Schedule, in item 3, replace “(Cap. 143)” with “1960”;
- (g) in the First Schedule, in item 4, replace “(Cap. 262)” with “2007”;
- (h) in the First Schedule, in item 5, replace “(Cap. 272A)” with “1995”; and

- (i) in the First Schedule, in item 6, replace “(Cap. 339)” with “2001”.
