### FOOD SAFETY AND SECURITY ACT 2025

#### FOOD SAFETY AND SECURITY ACT 2025 (COMMENCEMENT) (NO. 2) NOTIFICATION 2025

In exercise of the powers conferred by section 1 of the Food Safety and Security Act 2025, the Minister for Sustainability and the Environment makes the following Notification:

1. This Notification is the Food Safety and Security Act 2025 (Commencement) (No. 2) Notification 2025.

2. The following provisions of the Food Safety and Security Act 2025 come into operation on 28 November 2025:

(ii) paragraph (f) of the definition of “FSSA authorisation”;

(iii) paragraph (a) of the definition of “grant”;

(iv) paragraphs (b) and (c) of the definition of “identification card”;

(c) sections 3(2), (3), (4), (5), (6), (7) and (8) and 4;

(d) sections 5(1), (2) and (3), 7, 8, 9, 10 and 13;

(e) sections 14(1), (2) and (4) and 15;

(f) section 16(1), (2) and (4);

(g) Parts 5 and 6;

- (h) sections 142, 152, 153, 158, 159, 164, 165, 169, 170 and 171;
- (i) sections 177(2), 185 and 188;
- (j) the following provisions in Part 12:
  - (i) section 224(1) (only items 12, 13, 14 and 15 in the table) and (2);
  - (ii) sections 225, 227, 228 and 229;
  - (iii) section 226(1), (2), (3), (4), (5)(b)(ii), (6) and (7);

  - (xii) section 256(2)(a), (b) and (d);
